

The Inclosure of Prestbury.

THIS Indenture made the 10th Day of July, in the 6th Year of the Reign of our Sovereign Lord GEORGE II. by the Grace of God, of Great-Britain, France, and Ireland, King, Defender of the Faith, &c. Annoq; Dom. 1732. BETWEEN Kinard De La Bere of Southam, John Guise of Rencomb, Henry Window of Chosen, John Prinn of Charleton-Kings, and William-Henry Morgan of Cowley, Esqrs. William Cooper of Charleton-Kings aforesaid, Tho. Smart of Druffham, William Jayne of Frampton, William Durham of Willersley, and Anthony Edwards of Sberington, Gent. Robert Cox of Cheltenham, John Reynolds of Little Risington, and William Cooke of Halling, Yeomen, COMMISSIONERS nominated and appointed in and by an Act of Parliament made in the 4th Year of the Reign of his present Majesty, Entituled, *An Act for exchanging, Dividing and inclosing the Common Fields, Common Meadows, and Common and Waste Grounds within the Mannor of Prestbury, in the said County of Gloucester, of the one Part; The Right Hon. William Lord Craven, Lord of the Mannor of Prestbury aforesaid, the Right Hon. Francis Lord Conway, William Bagbott, Esq; Patron and Improprator of the Parish-Church of Prestbury aforesaid, Francis Welles, Clerk, Vicar of the said Parish Church of Prestbury aforesaid, Edmund Chamberlayne, Esq; Christopher Capel, Gent. and also all other the Commoners, Owners and Proprietors of Land within the said Mannor and Parish of Prestbury aforesaid, of the other Part.*

WHEREAS in and by the said Act of Parliament made as aforesaid in the 4th Year of the Reign of his said present Majesty King George II. over Great-Britain, &c. Entituled, *An Act for Exchanging, Dividing and Inclosing the Common Fields, Common Meadows, and Common and Waste Grounds within the Mannor of Prestbury in the said County of Gloucester; RECITING* (amongst other Things) that there is a large Waste or Common, called *Prestbury-Hill* and *Puckham-Sbrubs*, within the Mannor and Parish of *Prestbury* in the County of *Gloucester*: And that whereas the Owners and Proprietors of Lands there have Right of Commoning or Depasturing Cattle in or upon the Waste or Common called *Prestbury-Hill* and *Puckham-Sbrubs*, which, as the same then lay, could not be improved, and was of small Value to the Owners, and occasioned frequent Disputes in stocking the Commons to each Proprietor properly and respectively belonging. TO prevent which Inconveniencies, and better improving the said Waste or Common called *Prestbury-Hill* and *Puckham-Sbrubs*, It was and is Enacted (amongst other Things) that the said Waste or Common called *Prestbury-Hill* and *Puckham-Sbrubs* should before the 10th Day of November, which should be in the Year of our Lord 1732, at the proper Costs and Charges of the several and respective Proprietors of the same (except the said De La Bere, John Guise, Henry Window, John Prinn, Henry Morgan, William Cooper, Thomas Smart, Wm.

Jayne, William Durham, Anthony Edwards, jun. Robert Cox, John Reynolds, and William Cooke, Commissioners appointed by the said Act, and the Survivors of them, or any five or more of them, unto and amongst the several Proprietors in Proportion to their several and respective Right of Common therein belonging to him, her, and them, in as few Places as the same could reasonably be done: And that the said Commissioners in making their Allotments should have Regard as well to the Quality as Quantity of the Land to be allotted; and that each Proprietor should hold and enjoy his Share and Part in Severalty, freed and discharged from all Right of Common, and should have the same Estate and Interest in the Parts so to be allotted, as he, she, or they respectively then had in the Estate and Lands, in respect whereof such Allotments were to be made. And 'tis also further Provided and Enacted in and by the said Act, That it should and might be lawful to and for the said Commissioners appointed by the said Act, or any five or more of them, to allot the Right Hon. Wm. Lord Craven, Lord of the said Mannor of *Prestbury*, his Heirs and Assigns, for his particular Interests in the Wastes and other Commonable Lands, one Piece or Parcel of Land, Part of the said Waste, adjoining at the East End to the Inclosed Wood of the said William Lord Craven, call'd *Puckham-Wood*, having an Inclosed Ground belonging to *Puckham-Farm* on the South-Side, and a Way on the Top of the said Hill leading to *Winchcombe* on the West Side thereof, and to contain 100 Acres at the least, in lieu of all Right of Common which he had or might claim in the said Waste or other Commonable Lands lying in *Prestbury* aforesaid, and in full Satisfaction for the same. And also, That it should and might be lawful to and for the said Commissioners, or any five or more of them, to allot to the Vicar of *Prestbury* aforesaid, Ten Acres upon the said Waste or Common, to be by him and his Successors for ever held and enjoyed in Severalty, as an Addition to the said Vicarage. And further, That when the said Commissioners should have compleated and finished the Allotments, that the same should be fairly ingrossed and wrote upon Parchment, to be signed by the said Commissioners respectively, making the same under their Hands and Seals, or by the Survivors of them, or any five or more of them, and should be enrolled with the Clerk of the Peace for the said County of *Gloucester*, within three Months after such Allotments are made and compleated, to the end Recourse might be had to the same by any Person or Persons interested therein, for the Inspection and Perusal whereof One Shilling should be paid, and no more; and a true Copy thereof, for which no more should be paid than Four-pence per Sheet, should from Time to Time, and at all Times hereafter be admitted and allowed in all Courts whatsoever as legal Evidence of the same, as in and by the said recited Act, Relation thereunto being had, will (amongst other Particulars therein mentioned) more fully appear. And whereas the said Commissioners, or some five or more of them, having taken upon them the Execution of the said recited Act, and

in Pursuance thereof caused the said Waste or Common called *Prestbury-Hill* and *Puckham-Shrubs*, to be carefully measured over, and on such Admeasurement find the same to contain in Quantity 630 Acres, or thereabouts: And whereas they the said Commissioners, some five or more of them, having, at several Meetings for that Purpose holden within the said Mannor and Parish of *Prestbury* (Notice of such their Meetings being first given, as by the said Act is required) duly enquired into and considered the several and respective Estates of each and every the said Owners and Proprietors of Land within the said Mannor and Parish of *Prestbury*, and thereby made a just and impartial Calculation of their several and respective Rights and Interests of, in and to the said Waste or Common called *Prestbury-Hill* and *Puckham-Shrubs*, and according to such their Calculation (in making of which Regard was had as well to to the Quality as Quantity of the Land, as by the said Act is directed) Do adjudge, that the Allotments, Shares or Proportions of each and every the said Owners and Proprietors are and ought to be and remain to each of them respectively in manner as the same is herein after particularly allotted and set out. Now therefore this Indenture witnesseth, That the said *Kinard De La Bere*, *John Guise*, *Henry Window*, *John Prinn*, *William-Henry Morgan*, *William Cooper*, *Thomas Smart*, *William Jayne*, *William Durham*, *Anthony Edwards*, jun. *Robert Cox*, *John Reynolds*, and *William Cooke*, some five or more of them, in further Pursuance and Execution of the said recited Act, and by virtue of the Power and Authority to them for that Purpose thereby reserved and given, HAVE Granted, Assigned, Allotted and Divided, And by these Presents Do, or some five or more of them Do Grant, Assign, Allot and Divide to and amongst the said *William Lord Craven*, *Francis Lord Conway*, *William Bagbott*, *Francis Welles*, *Edmund Chamberlayne*, *Christopher Capel*, and other the Commoners, Owners and Proprietors of Land within the Mannor and Parish of *Prestbury* aforesaid, the said Waste or Common called *Prestbury-Hill* and *Puckham-Shrubs*, in Manner following, (That is to say)

TO and for the Right Hon. *William Lord Craven*, Lord of the said Mannor of *Prestbury*, his Heirs and Assigns, for his particular Interests in the said Wastes and other Commonable Lands within the Mannor and Parish of *Prestbury* aforesaid, 100 Acres, Part of the said Waste or Common call'd *Prestbury-Hill* and *Puckham-Shrubs*, lying together in one entire Piece, adjoining at the East End to the inclos'd Wood of the said *William Lord Craven*, call'd *Puckham-Wood*, having an inclosed Ground belonging to *Puckham-Farm* on the South Side, and a Way on the Top of the said Hill, leading, as the same is herein after set out, towards *Winchcombe* on the West Side thereof; and also 1 Acre and a half more next adjoining to the Quarry of the said Lord *Craven*, as the same is now set out, with free liberty to dig to the utmost extent thereof, in lieu of all right of Common which he hath, or may claim in the said Waste or other Commonable Lands in *Prestbury* aforesaid, and in full satisfaction for the same.

TO the said *Francis Welles* in his own Right, as Owner and Proprietor of Lands within the said Mannor and Parish of *Prestbury*, 12 Acres adjoining to the North Side of the said Allotment of the said Lord *Craven*, having the said Way leading towards *Winchcombe* on the West, and extending near to *Puckham-Shrubs* at the East End, and having the Allotment herein after made to him as Vicar of the said Parish Church of *Prestbury* aforesaid, on the North Side thereof.

TO *William Chestroe*, 2 Roods 27 Poles, having the last mentioned Allotment on the South, the Allotment here-

in after made to the said *Francis Welles*, for the said Vicarage on the North, the said Way leading toward *Winchcombe* on the West, and extending near to *Puckham-Shrubs* aforesaid on the East End thereof.

TO the said *Francis Welles*, as Vicar of the said Parish Church of *Prestbury* aforesaid, 10 Acres as an addition to the said Vicarage, as by the said recited Act is required and directed, having the aforesaid Allotment to the said *Francis Welles* in his own Right on the South Side, the aforesaid Way leading towards *Winchcombe* at the West End, and extending near to *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *Francis Welles*, as Vicar of the said Parish Church of *Prestbury* aforesaid, and in Right of the Glebe-Land belonging to the said Vicarage, 4 other Acres, having the last mentioned 10 Acres on the South Side, the Allotment herein after made to *Samuel Olliffe* and *Mary* his Wife on the North Side, and having the aforesaid Way leading towards *Winchcombe* on the West End, and *Puckham-Shrubs* aforesaid on the East End thereof.

TO the said *Samuel Olliffe* and *Mary* his Wife, 2 Acres 3 Roods 14 Poles, having the last mentioned Allotment on the South Side, the Allotment herein after made to *William Cooke* alias *Gibson* on the North Side, and having the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid on the East End thereof.

TO the said *William Cooke*, alias *Gibson*, for Land late *Kemmett's*, 4 Acres, 2 Roods, and 26 Poles, having the last mentioned Allotment on the South Side, the Allotment hereafter made to *John Timbrell* on the North Side, the aforesaid Way on the West, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *William Bagbott*, for the Lands purchased by him of the said *Will. Willis* as aforesaid, 4 Acres and 26 Poles, having the last mentioned Allotment on the South Side, the Allotment hereafter made to *William Hodges* on the North Side, and having the aforesaid Way leading towards *Winchcombe* on the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *William Hodges*, 2 Roods, and 26 Poles, having the last mentioned Allotment on the South Side, the Allotment hereafter made to *George Parsons* on the North Side, and having the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *George Parsons*, 1 Acre, 1 Rood, and 13 Poles, having the last mentioned Allotment on the South Side, the Allotment herein after made to *Richard Baldwin* on the North Side, and having the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid, at the East End thereof.

TO the said *Richard Baldwin*, 2 Acres, 1 Rood, and 12 Poles, having the last mentioned Allotment on the South Side, the Allotment herein after made to *Tho. Randle* on the North Side, and having the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *Thomas Randle*, 10 Acres, 3 Roods, and 13 Poles, having the last mentioned Allotment on the South Side, the Allotment herein after made to *Abigail Blis*, Widow, on the North, the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *Abigail Blis*, in Right of her own Estate, 2 Roods, and 39 Poles, having the last mentioned Allotment on the South-side, the Allotment herein after made to her in Right of the Estate of her late Husband *John Blis*, deceased, which she now claims under him, on the North-side, and having the aforesaid way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *Abigail Blis*, in Right of the Estate of her said late Husband *John Blis*, which she now claims under him as aforesaid, 2 Roods, and 26 Poles, having the last mentioned Allotment on the South-side, the Allotments herein after made to *John Newman* and *William Long* respectively, on the North-side, and having the aforesaid Way leading towards *Winchcombe* at the West End, and *Puckham-Shrubs* aforesaid at the East End thereof.

TO the said *John Newman* 25 Acres, having the last mentioned Allotment on the South End, the Allotment herein after made to *Edmund Goodrich*, and Part of the Land in Dispute between the Parishes of *Bishops-Cleeve* and *Prestbury*, at the North End, and having the Allotments herein after made to *Edmund Smith* and *William Wood* on the East, and the Allotments herein after made to the said *Wm. Long*, the Heirs of *Edward Cooke*, alias *Gibson*, and to *Henry Acreman*, respectively, on the West Side thereof.
